[OLD VERSION] Notice of an extraordinary general meeting must specify <mark>the place</mark>, day and hour of the meeting and the nature of the business to be conducted, and <mark>must be delivered at least 7 (seven) days in advance of the</mark> meeting date to the address of each member, and posted at Carson on the bulletin board adjacent to the main office and on the Carson and Carson PAC websites.

5. [NEW VERSION] Notice of an extraordinary general meeting must specify the electronic meeting attendance instructions or place of attendance, day and hour of the meeting and the nature of the business to be conducted, and must be delivered via email (or other means deemed appropriate by the PAC Executive) at least 7 (seven) days in advance of the meeting date to each member of the PAC, and posted on the Carson and Carson PAC website.

the executive members and placed with the minutes of the executive members, is as valid and effective as if regularly passed at a meeting of the executive members.



The girls team therefore seems to need the money more urgently.)</li> </ul>
